XCCR Instructor Requirements

Minimum requirements to become and remain an approved iQsub XCCR Instructor

A.

If the candidate is a **CCR Instructor**, then the candidate must complete the following to be approved as an XCCR Instructor:

1. A minimum of 50 logged diving hours on XCCR as an XCCR Diver, certified at a recognized training association (IANTD, TDI, PSAI, CMAS, ANDI).
2. Have own complete XCCR unit in factory condition (no modifications with non-original parts) before the start of the training.
3. Complete the XCCR Instructor Crossover with a factory approved XCCR Instructor Trainer:
 - a. Assist with minimum of one XCCR diver course with approved XCCR IT.
 - b. Conduct a minimum of one XCCR diver course under the supervision of approved XCCR IT.
 - c. Agree to comply with the standards of the association (IANTD, TDI, PSAI, CMAS, ANDY), which are confirmed by iQsub Technologies.

B.

If the candidate is **not yet any CCR Instructor**, then the candidate must complete the following to be approved as an XCCR Instructor:

1. A minimum of 100 logged diving hours on the XCCR as an XCCR Diver, certified at a recognized training association (IANTD, TDI, PSAI, CMAS, ANDI).
2. Be an active Advanced Nitrox Instructor with a recognized training association (IANTD, TDI, PSAI, CMAS, ANDI, RAID).
3. Own a complete XCCR unit in factory condition (no modifications with non-original parts).
4. Complete the full XCCR Instructor Course with a factory approved XCCR Instructor Trainer:
 - a. Assist with minimum of one XCCR diver course with approved XCCR IT.
 - b. Conduct a minimum of one XCCR diver course under the supervision of approved XCCR IT.
 - c. Agree to follow the association's standards (approved by iQsub Technologies).

Once you have completed the above, do the following to REMAIN an XCCR Instructor:

1. Represent and promote XCCR and iQsub Technologies in a good, positive and professional manner.
2. Notify iQsub Technologies directly and privately of any complaints or issues with an XCCR or other company related matters.
3. iQsub Technologies reserves the right to approve or disapprove any instructor as factory approved XCCR Instructor at its sole discretion.
4. No deviations from the above standards are allowed without prior written approval from iQsub Technologies.
5. The candidate must read, understand, agree to, and comply with all of the above requirements in order to maintain active, approved instructor trainer status and remain listed as a factory approved iQsub XCCR Instructor Trainer.
